### 3. Composition / Information on Ingredients

Pressure-sensitive adhesive applied to a solid substrate.

Adhesive formulation contains non-hazardous components. Exact composition is withheld as a trade secret in accordance with OSHA 29 CFR 1910.1200(i).

### 4. First-Aid Measures

**Eyes:** Flush with water for at least 15 minutes. Seek medical attention if irritation persists.

**Skin:** Wash with soap and water. Mineral oil may be used to assist removal if necessary.

**Ingestion:** Do not induce vomiting; seek medical attention if symptoms occur.

**Inhalation:** Not an expected route of exposure under normal use.

### 5. Fire-Fighting Measures

**Extinguishing Media:** Water spray, foam, CO<sub>2</sub>, dry chemical.

**Hazards:** Carbon monoxide and carbon dioxide may be produced during combustion.

No special handling required under normal use. Store in a cool, dry place.

No PPE required under normal use.

## **9. Physical and Chemical Properties**

Solid; light amber; Odor: None to mild; may include peanut butter or vanilla scent depending on product variant. Specific Gravity ~0.98; Flash Point >400°F (204°C). Insoluble in water.

## **10. Stability and Reactivity**

Stable under normal conditions. No hazardous reactions expected.

## **11. Toxicological Information**

No acute toxicity expected from the finished product under normal conditions of use. Supplier data indicates potential hazards associated with molten adhesive during industrial processing only.
